Your appeal must be signed and include supporting documentation (see below). Incomplete appeals will be denied and returned to you. You will be considered a **Self-Pay** student and will need to make payment arrangements with the Bursar's Office.

Appeals will be reviewed by the FASAP committee to determine the student's eligibility. Notification of the decision will be in writing, and sent to your LOC email, normally within ten days of the appeal.

Supporting Documentation for Extenuating Circumstances

Extenuating circumstances are formally defined as: "circumstances beyond the student's control which cause the student to perform unsatisfactory in their coursework or examinations than otherwise might have been expected.

Medical / Health Issues / Serious Family Emergency – Physician's statement or copies of medical records along with two letters to verify situation.

Death of an Immediate Family Member – Copy of Death Certificate or Obituary (Relationship must be verifiable).

Divorce – If pending, provide a letter from an attorney on letterhead. If final, provide a copy of the divorce decree.

Homelessness – Must provide two letters to verify the situation.

Major Accident or Injury (Self, Child or Parent) - Provide police report or Physician/Medical Records if injured.

Work Commitments (Preventing Student from Attending Class) – Must have statement from employer on company letterhead.

Loss of Transportation (Preventing Student from Attending Class) – Provide estimate or documentation from repair company, if being repaired; If not, provide two letters to verify situation and estimated dates for repairs to be completed.

Long Term Jury Duty – Provide copy of jury duty notice including expected service time.

Incarceration / Legal Issues – Provide copy of release papers showing incarceration dates; Letter from attorney, on letterhead, if applicable; Court documents, if applicable.

Crime Victim / Unexpected Disaster – Provide police report or official record of disaster.

Circumstances NOT Taken Into Account

Minor Ailments and Illnesses such as colds, coughs, sprains & headaches

Personal Disruptions or Events (which could have been anticipated) – Holidays, Weddings, Single Parenting, Lack of Childcare, Repeated Transportation Issues, Moving, Employment, Religious Holidays or Festivals which are usually known in advance.

Study-Related Circumstances – Computer Failure, Printing Problems, Unavailability of Books or Photocopying Problems as these should be factored into your workload.
